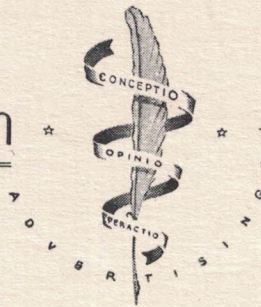


Dear Bill:

APPLICATION AND CONTRACT FOR RADIO BROADCAST OF POLITICAL PROGRAMS

I, Henry M. Jackson, a legally qualified candidate
for the office of Congressman from the Second District, in the November
5, 1946 election, do hereby make request of **QUEEN CITY BROADCASTING COMPANY, INC.**,

hereafter referred to as **KIRO**, for political broadcast time as follows:
HOURS AND DATES OF BROADCASTING:

7:45-50 PM - October 22.

TERMS: Cash in advance at the following rate:

1 Class A 5-min pgm @ \$45.00

I represent herewith that the monies tendered herewith in advance payment for the above described broadcast time
has been furnished by Myself and you
are directed to so describe the sponsor in your radio log, or otherwise, and to announce the program as paid for by
such person or persons.


I further agree that the hours and dates of broadcast, above set forth, become binding on **KIRO** only upon payment in full of the
charges herein provided for and subject to the general conditions of this contract, and the provisions of the Federal Communica-
tions Commission Act of 1934, as amended, and the rules and regulations of the Federal Communications Commission governing
such broadcasts. This contract will not become binding on **KIRO** until it has been signed by a duly authorized official of the
Company.

**I agree that all written copy of the material to be broadcast will be submitted to KIRO at its studios not less than twenty-four
hours in advance of each broadcast. Failure to furnish copy within said time shall entitle KIRO to refuse to allow the use of
its broadcast facilities, but KIRO shall be under no obligation to return any amount paid in advance for broadcast time, nor
shall I be relieved of liability to pay for said time if the same has not already been paid. I agree further to delete from any copy
submitted and to refrain from using over the broadcast facilities of KIRO any matter considered by KIRO to be slanderous or
defamatory.**

Written copy will be submitted for each broadcast whether given in person or by transcription and whether it is a rebroadcast of
an earlier program.

In the event any speaker designated by me to use **KIRO's** facilities herein contracted for is not one of the signers of this contract,
I agree that such speakers will agree in writing and prior to broadcasting to the terms hereof in respect to protection of **KIRO**
against claims of third parties for violation of or damage to their rights.
